

**GENERAL POWER OF ATTORNEY
AND AUTHORIZATION FOR RELEASE OF PERSONAL INFORMATION**

BONDS(S) and all rewrites _____

TO ALL PERSONS: be it known that I, _____, Grantor do hereby make and grant a general and irrevocable power of attorney to Ajax Bail Bonds, Inc., dba Ajax Bail Bonds or their assigns, and do thereupon constitute and appoint said individual as my attorney-in-fact.

My attorney-in-fact shall have full powers and authority to do and undertake all acts on my behalf that I could do personally, with full power substitution and revocation, including, but not limited to by said the right to sell, deed, buy, trade, lease, mortgage, assign, rent or dispose of any of my present or future real or personal property, including motor vehicles, motor homes, boats, airplanes, trailers, sea-doos, jet skies, ATV, etc.; the right to execute, accept, undertake and perform any and all contracts in my name; the right to retain any accountant, attorney or other advisor deemed necessary to retire debts as a result of this bail contract, the right to access all accounts, bank, savings, retirement, certificate of deposit, etc. until all debts are retired. With respect to any obligation between myself or any other obligor and the agency, it is my clear and expressed intention that any debts incurred as a result of a breach of contract be retired by law of this power of attorney in fact has full authority to retire any outstanding debts, as he/she deems necessary. I hereby grant Ajax Bail Bonds, Inc., dba Ajax Bail Bonds, a security interest in the following:

_____ for the purpose of securing any and all amounts which may come due under this obligation. I understand that this agreement authorizes Ajax Bail Bonds, Inc., dba Aardvark Bail Bonds, to place its name on my vehicles' titles as lien holder for the purpose of perfecting this security interest. I further agree that in the event I acquire another vehicle prior to satisfying my obligation, it too shall secure my duties under this obligation. I understand that the power of attorney will authorize Ajax Bail Bonds, Inc., dba Ajax Bail Bonds to take any steps necessary to perfect its security interest, i.e., duplicate title and/or lien holder status on any new or other vehicle(s).

I hereby waive any and all rights I have under Title 28 Privacy Act-Freedom of Information Act, Title 6, Fair Credit Reporting Act, and such local and State law. I do hereby authorize, voluntarily and without coercion, the review and full disclosure of all records concerning myself whether the records are of a public, private or confidential nature, including, but not limited to, the right to receive records, telephone, utilities, credit, social security, criminal, civil, DMV, school, medical, employment, pre-employment records, NCIC records, and the recollections and/or records of attorney at law, or other counsel representing me or another in any case, civil or criminal in which I have or have had an interest.

This power of attorney shall not be affected by disability of the Grantor. Until Ajax Bail Bonds, Inc., dba Ajax Bail Bonds or its agents, have been supplied with an original and verified certificate of discharge and/or exoneration by the Court of Jurisdiction on the surety bonds listed, and ALL financial obligations by the Grantor have been met, this power of attorney shall remain in full force.
